Financial Update: Jeff

- 2022 Revenue: \$5694, Expenses: \$2734, Overall, \$2960 Balance. Approved.
- Action: Jeff is working on getting the bank account online and then accepting online
 payments via the website with Vemo business or another similar application. There will be fees
 for this direct payment method, so we will need to consider if we add to dues.
- For financial administration, Jeff is using excel, which will become cumbersome and not meet our reporting needs if we receive our 501(c3) status or receive grants. Two options are being considered:
 - QuickBooks (\$87/mo) ability to import data from the bank, match it with payments made, and send invoices and reporting with good support.
 - Zip books (\$55/mo or \$35/mo options). Less functionality compared to QuickBooks with minimal support.

Action: Jeff to continue to investigate and bring options to future meeting.

Organizational Steps Toward becoming a 501(c3): Linda

- Goal is to obtain 501(c3) status so SAA can apply for grants.
- Proposed bylaws (Copy to be emailed to all members):
 - Board of Directors (BoD) consists of President, Vice President, Treasurer, and Secretary as well as other members at large (recommended 1-3).
 - Members at Large:
 - In meeting voted on and agreed to 3 members at large for SAA. (There would be a commitment of at most 4 meetings per year. Read proposed bylaws for duties.)
 - To date volunteered candidates for 3 members at large: John O'Donnell, Denise Schlesinger,
 - Proposed Term Limits of BoD 1 (one) two-year term and not for more than 2 (two)
 consecutive terms in a specific position. (Half of initial BoD will be 1yr to ensure there isn't a
 full turnover of BoD at end of term.)
 - o Proposed fiscal year Jan thru Dec. Budget will be presented Qtr1 of year.

- o Contact Linda Hubbard if you are interested in becoming a BoD member at large.
- Review proposed bylaws and contact Linda Hubbard if you have any questions.
